Faculty of Dentistry, Prince of Songkla University and Faculty of Dentistry, Niigata University believe that mutual benefit can be derived from scholarly interaction, cultural interchange, cooperative research, and other forms of academic collaboration, as well as possible student and staff exchanges. Both institutions see advantages in the development of strong academic links and relationships, and agree to establish ties of friendship and cooperation for the purpose of promoting mutual understanding and academic, cultural, and personal exchange.

- The following general aims of cooperation are considered to be desirable and feasible:
 - a) To identify opportunities for exchange of faculty, research staff and undergraduate students
 - b) To establish programs that will enable interested and qualified students and university personnel to pursue either short-term or extended programs of study in each other's institutions and to facilitate visits by authorized officials from each university
 - To promote exchanges in graduate studies, continuing education, and flexible/distance learning
 - d) To exchange information materials in fields that are of interest to both parties
 - e) To cooperate in training projects for specific areas of research and to cooperate in clinical training
 - f) To provide consultation services for curriculum development
 - g) Other areas of interest and collaboration as shall be identified
- This Agreement will serve as a general framework for cooperation between two parties.
 A specific Agreement for Collaboration signed by both institutions will describe the terms and conditions of the collaboration.
- A designated person at each institution shall oversee and facilitate implementation of this Agreement in cooperation with other appropriate administrators at the respective institutions.
- The present Agreement shall enter into force when signed by both parties and will remain effective for 5 (five) years in the first instance. Either party may bring the Agreement to an end by giving 1 (one) year's written notice to the other. Any modification of the present text during the tenure of this agreement shall be agreed between the parties and submitted for approval to the relevant authorities in both countries.
