



**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE FACULTY OF DENTISTRY, PRINCE OF SONGKLA UNIVERSITY
AND
KYUNG HEE UNIVERSITY SCHOOL OF DENTISTRY**

The agreement for cooperation will become effective for a period of Ten years upon the date of signature by the representatives of the two institutions.

The agreement may be amended or revised at any time by the mutual, written consent of the parties. It may be terminated by either party by providing six months' notice to the other of its intention to terminate.

This agreement is intended to promote international collaboration to advance dental education, dental practice, and oral health, and to provide the basis for a collegial relationship between The Faculty of Dentistry Prince of Songkla University, Hat Yai, Thailand and Kyung Hee University School of Dentistry, Seoul, Korea.

Subject to approval by the appropriate university authorities, represented by Dean Chairat Charoemratrote of the Faculty of Dentistry, Prince of Songkla University, and Dean Young Guk Park of the Kyung Hee University School of Dentistry, both parties agree to enter into a collaborative relationship for the benefit of their respective communities.

Both parties agree upon the following:

1. To collaborate in the field of health scientific research, education, services, cultural exchange and practical training.
2. To exchange faculty and students for short- or long-term research and educational purposes.
3. To foster collaborative projects between faculties and students of both parties.
4. To share information about research, education resources and programs.
5. To organize symposia, conferences, short courses and meetings on research issues.
6. Continuing education that contributes to professional development and other programs of mutual benefit.

Faculty from each party may undertake short- or long-term exchanges for collaboration in research, education, and health services. Appointments, titles and qualifications will be agreed upon in advance, after due consultation.

Students and fellows from both parties may be admitted for matriculation toward advanced degrees, and students may also be welcomed for exchanges in non-degree but accredited programs. Qualifications, requirements, and limitations will be agreed upon in advance, and students will be selected through due procedure by both parties.

COSTS

Both parties agree on the following:

1. In the case of cooperative projects, cost will be discussed by both parties.
2. In the case of exchanges of faculty or students, the applying university or persons should be responsible for the cost.

INSURANCE

Faculty members and exchange students will be required to buy overseas insurance before departure as mandated by the regulations of the host institution and/or country.

If visiting students or faculty participate in hands on care or education, universal standards for disease transmission will be followed, the health screening and vaccination requirements of the host institution will apply, and relevant laws and policies concerning patient privacy will be followed. Professional liability insurance will be the responsibility of the institution that employs or enrolls a visitor, unless otherwise agreed. Professional licensing rules of the host institution's jurisdiction will apply to faculty and student visitors.

LIABILITY

Faculty and students shall abide by policies of both the host and sending universities regarding liability insurance, which will cover expenses for emergency medical care, hospitalization and repatriation for trips overseas, as well as worker's compensation coverage where applicable.


This MOU is effective from Jan.01,2016 to Dec.31,2025(ten years), subject to termination earlier by either institution upon written notice to the other party.
