

International Exchange Programme

between

University of Gothenburg, Institute of Odontology

and

Faculty of Dentistry, Prince of Songkla University, Thailand

The University of Gothenburg, Institute of Odontology (GU), Sweden, and the Faculty of Dentistry, Prince of Songkla University (PSU), Thailand hereby agree to promote academic and educational collaboration and exchange between the two universities, and between Sweden and Thailand, and to contribute to the advancement of dental and medical sciences.

CONTENTS OF THE EXCHANGE PROGRAMME

1. Each institution will promote the following exchange programmes.

- (1) The exchange of academic and administrative staff.
- (2) The exchange of undergraduate and graduate students.
- (3) The organization of joint research programmes, and joint conferences and seminars.
- (4) The exchange of academic literature, research reports, academic publications and other academic information.
- (5) Other educational and academic exchanges or activities deemed appropriate by both institutions.
- (6) Financial agreements.

Both universities recognize that their current levels of funding will restrict the extent to which financial support can be given to the above proposals for seminar

cooperation. Consequently in the implementation of the proposals, both universities understand that -

- a) Financial arrangements for collaborative research projects and other related cooperation e.g. organization of seminars etc., will have to be negotiated separately and are subject to availability of funds.
- b) Costs of travel between PSU and GU and accommodation expenses in respect of visiting staff will remain the responsibility of the staff concerned except where the sending institution determines otherwise.
- c) Visiting students, will be responsible for meeting the cost of their travel and all other incidental/local expenses (including payment of fees) unless otherwise mutually agreed upon separately. The host country will be responsible for meeting the cost of accommodation.
- d) Gothenburg will support two visiting professors per year who come to PSU to help with teaching, education, and supervising PhD students at PSU.
- e) PSU will cover the cost of domestic flight travel, Bangkok-HatYai-Bangkok, as well as accommodation in HatYai for the visiting professors from Gothenburg.
- f) This agreement does not preclude either one or both institutions from obtaining travel grants from organizations and foundations or to seek an external source of funding in support of any aspects of this programme of cooperation.

IMPLEMENTATION OF THE EXCHANGE PROGRAMME

2. For the development and implementation of specific exchange and joint programmes based on this agreement, each programme shall be separately negotiated between the two institutions and agreed upon.

TERMS OF THE AGREEMENT

3. This agreement shall become effective when the latter of the two signatories who are representatives of their respective institutions affixes his or her signature, and shall be in force for a term of five years. The agreement shall be renewed for another term

of five years, provided that neither institute who is party to this agreement gives notice of termination of this agreement to the other at the end of each term.

REVISION AND TERMINATION OF THE AGREEMENT


4. The two universities must consult each other when they wish to revise or terminate the agreement. A notice period of one year is required before termination becomes effective.

LANGUAGE USED


5. This agreement shall be written and signed in an English language version. In the event of any disagreement of any term herein, the parties shall resolve such disagreement by consultation.




